

WELCOME TO THE 19TH ANNUAL Blue Ridge BBQ FESTIVAL

The 19th annual Blue Ridge BBQ Festival, presented by the Carolina Foothills Chamber of Commerce, will be held Friday, June 8, and Saturday, June 9, 2012, at Harmon Field in Tryon, NC. This event is the Official North Carolina State Barbecue Championship Cookoff as proclaimed by North Carolina Governor Beverly Perdue, and is a Kansas City Barbecue Society sanctioned contest.

This Festival is a "Cookers' Contest," with \$20,000 **PLUS** in prizes. Money will be awarded in the four KCBS categories as well as **Smithfield Rib Super Series**, Whole Hog, Anything But, and Dessert contests. Awards will include Grand Champion and Reserve Grand Champion and the governor's Trophy for NC teams. There will be more than 50 opportunities to take home money and trophies.

The Contest

The **Blue Ridge BBQ Festival** is sanctioned by the Kansas City Barbecue Society (KCBS) and their representatives will be present. Judging starts at noon on Saturday, June 9, using the blind judging technique. The contest consists of the four KCBS categories which are required entry in order to qualify for the Grand championship as well as for the North Carolina Governor's Award.
