SEND NO MONEY NOW. If you are selected as a vendor for this event you will be contacted by mail and sent festival rules and other details. If you are selected, we will need a security deposit of \$300.00 that will be returned by mail within 30 days after clean-up inspection. There will be a charge of \$225 for each booth space, minimum of 10 ft. store front x 20 ft. deep. Additional space is available at the rate of \$20 per linear foot. Food vendors will also pay an additional 20% of gross sales to the Carolina Foothills Chamber of Commerce. **CASH SALES OF FOOD ARE PROHIBITED!** Each applicant who is accepted will be responsible for the equipment within their booth, cleanliness, proper staffing during the event and clean up at the end of the event. The Polk County Health Department will require a temporary permit for all for-profit food vendors—a \$75.00 fee applies to permit. **Absolutely no Styrofoam permitted.** Only compostable serving plates and utensils are permitted in keeping with our “Going Green” initiative. No plastic or styrofoam cups, plates, forks, spoons or knives.

APPLICATIONS MUST BE RECEIVED NO LATER THAN MARCH 1, 2012, IN ORDER TO BE CONSIDERED.
